The Court hereby modifies and enhances Administrative Order 1-2020, effective immediately, and taking Judicial Notice of Ohio House Bill #197, the COVID 19 Emergency Response Law, signed by Governor DeWine today March 27, 2020. Further, the Court finds that court hearings increase the risk of contamination due to congregation. The Court finds it necessary that additional steps need to be taken to protect the public and the Court's Staff. The Court cancels all scheduled hearings for March 30, 2020 – April 3, 2020. Attached to this order is said Hearing Schedule that is continued with this order. Said hearings will be rescheduled. The Court will continue to remain open as outlined in Administrative Order 1-2020 and conduct arraignments.

Pursuant to Ohio Revised Code § 2945.72 (H) and Ohio House Bill #197 the Court hereby extends the time for and continues all preliminary hearings, pre-trials, trials, including jury trials for the week of March 30, 2020 – April 3, 2020.
